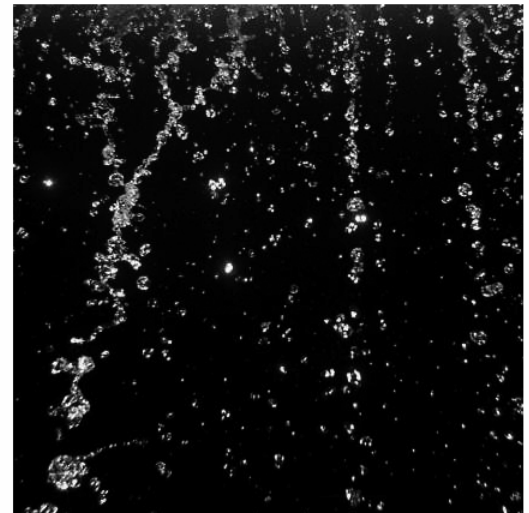

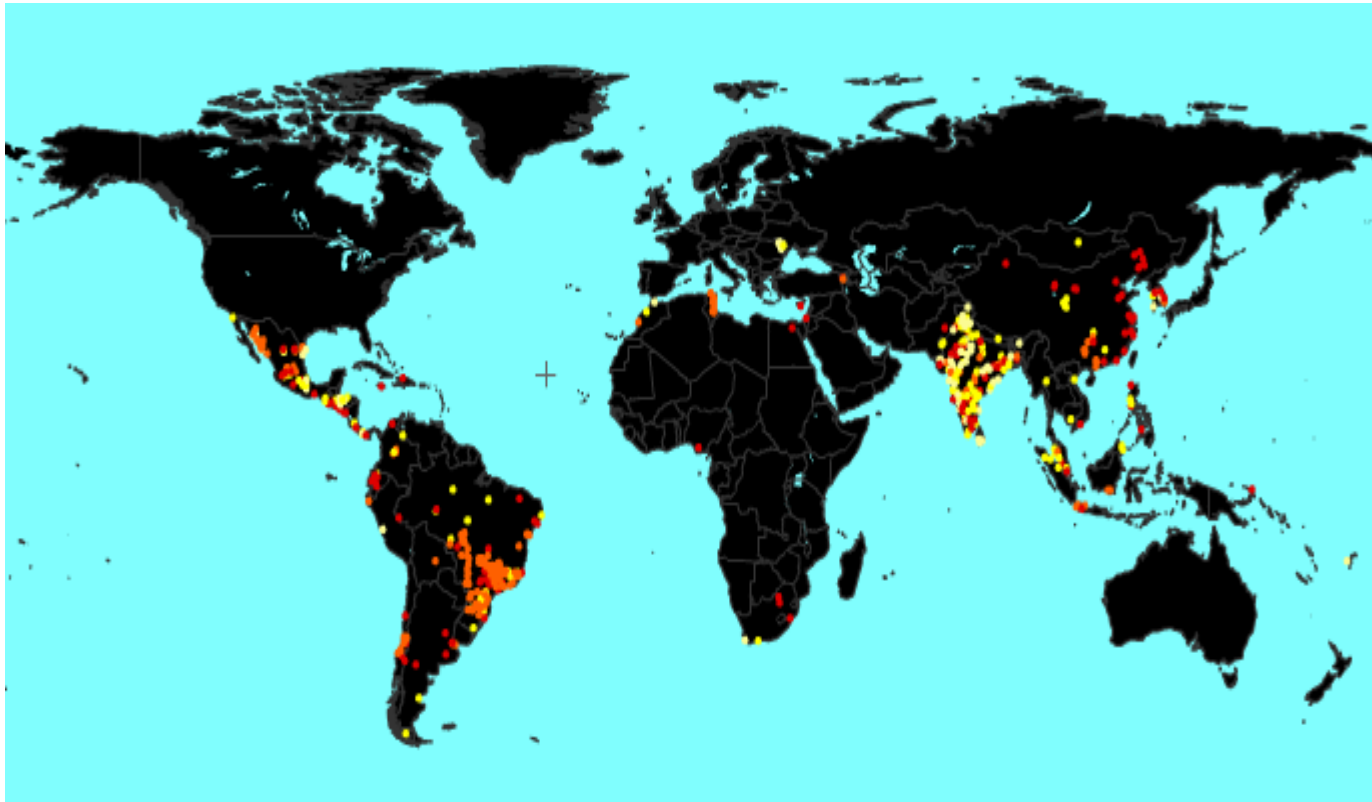


UNFCCC COP/MOP2 – 13 November 2006

403 CDM project activities,

46 Project activities requesting
registration,



More than 1,300 activities in the CDM pipeline (incl. above),
- around 1,500 million CERs expected by end of 2012
(assumption: no extension of crediting periods)

CDM Bazaar | Update



- “Make publicly available relevant information, submitted to it for this purpose, on proposed CDM project activities in need of funding and on investors seeking opportunities, in order to assist in arranging funding of CDM project activities, as necessary” (EB 21 Report)
- Initial discussion with UNEP RISOE and agreement to cooperate on the development and implementation
- Plan to develop a web based platform for such exchange of information and, in the future, a match making activities

CDM Bazaar | Update



- Call for public inputs was launched last September for two weeks with eight received:
- “Will maximize investment opportunities and reduce efforts and costs ... should have a friendly interface ... easy to use ... add a module dealing with "Capacity Development" or "Technical Support"
- “Welcome and look forward to Bazaar ... user maintained data welcome ... allow all projects at various stages to be included”
- “Bazaar is beyond the mandate of the EB & duplicates what the private sector is already doing”



- EB recommendations to COP/MOP2 indicated the CDM Bazaar as a tool to address regional distribution of CDM project activities
- Another round of discussions at the next EB meeting in December
- Further discussions and planning with UNEP RISOE
- Preliminary version to be launched as soon as possible

CDM Bazaar | Update



- The Bazaar will cover supply of and demand for CDM projects, i.e. the actions taken by project sponsors, developers and 'investors'
- The Bazaar will be a global 'virtual information exchange place' open to all interested parties. It aims to be a facilitating initiative that will help to reduce transaction costs in the CDM project cycle as well as to encourage increased information exchange and dialogue among current and potential future project participants
- The Bazaar will function as a cost-free service
- The Bazaar will not be a 'deal-maker' as this function lies within the realm of private sector intermediaries and service providers.
